### GENERAL DESCRIPTION

The property comprises of a substantial office premises arranged over four floors and occupying a town centre location. The property has recently been the subject of a substantial refurbishment programme and now offers superbly presented serviced office accommodation with a manned reception. There is an internal intercom system in the main foyer for when the main reception area is closed for use by the tenants and their clients. The property has extensive frontage to King Street and is immediately opposite the Jubilee 2 sports club, all of the town centre amenities are on the door step. King Street is accessed via the Nelson Place roundabout which forms part of the ring road (A52).

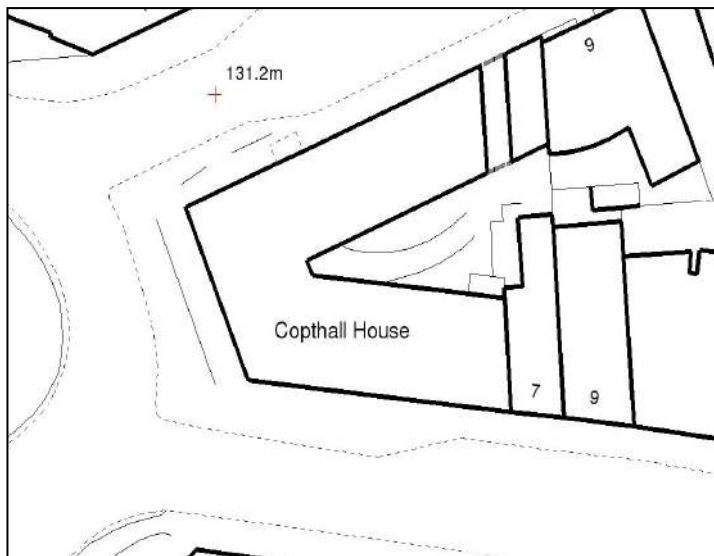

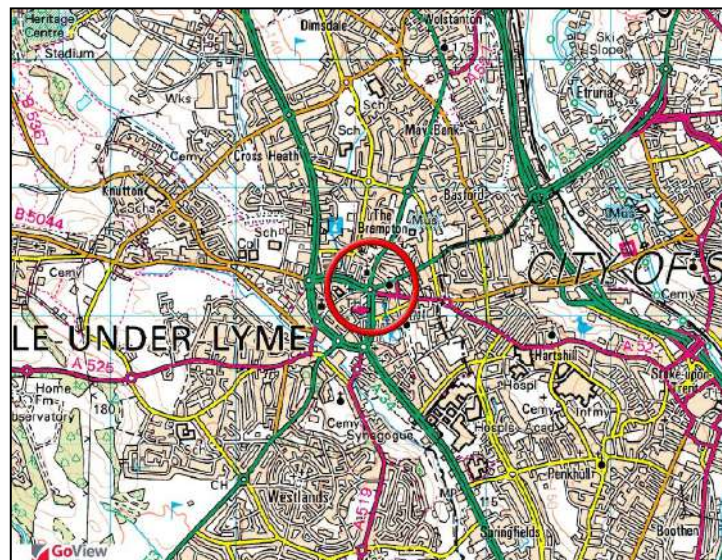
ORDNANCE MAP
